
THE LATEST ISSUE OF THE ERMENİ ARAŞTIRMALARI JOURNAL IS OUT

We are pleased to announce that the 63rd issue of the *Ermeni Araştırmaları* journal has been published. This issue consists of five articles in total, including an editorial and four research articles.

As always, the first article in the 63rd issue is the editorial titled **Olaylar ve Yorumlar** (*Facts and Comments*) by Alev Kılıç. It covers Turkey-Armenia relations as well as domestic and international developments concerning Armenia between April-August 2019. In this article, Kılıç focuses on the issues such as Prime Minister Nikol Pashinyans feud with previous administrations, the tensions between Pashinyan and the so-called administrators of Nagorno-Karabakh, and his efforts to get close with other international actors despite Armenias close ties Russia.

The second article titled **Berlin Antlaşmasının Birinci Murahhası Aleksandır Karatodori (Theodori) Efendinin (Paşa) Berlin Antlaşmasının Ermenilerle ilgili 61 Maddesine Dair Görüşleri** (*The Views Of The Chief Negotiator Of Berlin Treaty Alexander Carathéodory [Theodori] Efendis [Pasha] On The Article 61 Of Berlin Treaty Conserving Armenians*), Taner Aslan deals with activities and contacts of the Armenian Delegation during the 1878 Berlin Conference. Aslan evaluates this process in reference to the views of the Ottoman Empires Chief Negotiator, Alexander Carathéodory Pasha.

Salih Tunçs article titled **1908 Trabzon Seçimlerinde Ermeniler** (*Armenians in the 1908 Elections*) is an archive research. Tunç, who based his study on the reports of French consul in Trabzon of that time, evaluates the impacts of the 1908 elections on the Armenian community in Trabzon.

In the fourth article titled **Güney Kafkasyada İki-Taraflılığın İzlerini Bağlamsallaştırmak: Ermenistan ve Gürcistan Örneği** (*Contextualizing the Traces of Bilateralism in the South Caucasus: The Case of Armenia and Georgia*), Didem Ekinici focuses on the relations between Georgia and Armenia after 1992 in the context of the concept of bilateralism.

The last article titled **Geçici Sevk ve İskân Kanunu Sonrası Osmanlı Hükümetinin Osmanlı Ordusunda Görevli Ermeni Asker ve Ailelerine Yönelik Uyguladığı Politikalar** (*The Ottoman Governments Policies Over The Armenian Soldiers In The Ottoman Army And Their Families After The Temporary Relocation And Resettlement Law*) by Güzin Çaykırın is another archive research in this issue. In this study, Çaykırın evaluates the policies of Ottoman Empire on Armenian soldiers and their families during the period of the 1915 Relocation and Resettlement Law.
